

## ESET UK - Website Use Policy

Welcome to [www.eset.co.uk](http://www.eset.co.uk), the online anti-malware download and purchase platform operated by ESET UK on the Website [www.eset.co.uk](http://www.eset.co.uk) (the “**Website**”).

ESET UK is the trading name of QNH Ltd registered in England and Wales No. 7184889 with its registered office at 242 Charminster Road, Bournemouth, BH8 9RP (references to “us”, “we” or “our” being construed accordingly).

The following terms and conditions (“**Terms**”) specifically apply to your use of the Website (references to “you” or “your” being construed accordingly).
